### WAIVER AND RELEASE AND ASSUMPTION OF RISK

The Clubs at St. James understands that you ("the Participant") would like to participate in the Puppy Plunge event ("the Event") to be held on Wednesday, November 4, 2020. Please take note that The Clubs at St James, its officers, directors, agents, and/or employees (collectively referred to herein as "the Clubs") are unable to and will not accept any liability or responsibility whatsoever for any damages or injuries sustained by you or your dog while attending the Event, whether occasioned by the conduct of other dogs, their owners, or otherwise. By signing below, and in consideration of us allowing you and your dog to attend and participate in the Event, you hereby (a) release the Clubs from any liability whatsoever in respect of any damages or injuries which you or your dog may suffer while attending or participating in the Event and (b) agree to indemnify and hold the Clubs blameless for all claims, damages, or injuries arising from any act occasioned by you or your pet. Please know that the Clubs reserves the right to remove any persons or dogs from the Event for any behavior which the Clubs, at their discretion, deem inappropriate. Without in any way limiting your release and indemnification of the Clubs as provided for above, by signing below you additionally and specifically agree as follows:

This includes any liability for damages suffered by others because of any conduct or action by my dog or myself.

1. Dogs must wear a collar with proper ID at all times. All dogs MUST enter and exit the Seaside Pool facility on a leash. Owners must hold and control the leash/dog at all times when not in the pool. No lifeguard will be on duty.
2. All dogs must have current rabies shots and vaccinations required by law.
3. This is a Dog Swim Only. Chemical levels have been lowered to a safe level for dogs, but not for human swimming. Humans are not allowed in the pool except for an emergency.
4. A hose is provided to rinse your Pooch before & after the swim to protect their coat and the water clarity.
5. Doggie Doo Do's...Dog Owners are responsible for picking up dog waste. Doggie bags will be provided at the Puppy Plunge Station.
6. Socialized dogs only. We will ask you to take your dog home if they are uncontrollably barking, exhibiting aggressive behavior with other dogs or human friends, etc.
7. Do not bring dogs that have health conditions that may endanger themselves or others.
8. Dogs in heat may not participate.
9. You must sign this Waiver for your Dog to participate.
10. Failure to comply with the above mentioned will result in The Clubs asking you to take your furry friend home.
